### **Spaejari Award**

The Youth Committee approves the below update of the award and wants board and budget approval as well as the website updated.

## **Spaejari Award – Annual Youth Award**

Spaejari is the Icelandic name of the Icelandic endurance horse commonly known as Remington. Spaejari is known for his determination, passion and indomitable will. This award is intended to inspire and encourage these same qualities in our youth who enjoy spending time with Icelandic Horses.

- Eligibility is USIHC member under 18 years of age
- The horse being written about needs to be USIHC registered.
- It can be a USIHC or FEIF supported event
- It can include a registered Icelandic at an All Breeds Show or as a Breed Ambassador.
- Award is given to youth who clearly demonstrate their commitment and love for Icelandic horses.
  - Any kind of riding activity, including recreational trail riding showing, driving, gymkhana, endurance riding, dressage, team penning, jumping, trail trails and competitive trail riding. Can include participation in 4 H programs, volunteering with therapeutic riding programs, rescue programs and adoption programs. Simply training or caring for Icelandic horses can also show the requisite commitment.

## **How to Qualify:**

- Submission of a youth written article for publication in the Quarterly with an accompanying good resolution photograph.
- Youth articles submitted to the Quarterly will be reviewed at the end of the calendar year and the Quarterly Staff with the Youth Committee approval will award one winner.
- The youth writing the article need not own the Icelandic horse to submit an article.
- An award and \$50 goes to the winner.

## **FEIF Youth Cup (FYCup) Rules and Procedures for Riders, Country Leader and Team Leader 2016**

### **What is the Youth Cup?**

The FEIF Youth Cup is a seven-day youth competition held every other year in Europe or Iceland. The YC is a well-supervised event that takes place after 4 days of training with prominent and experienced Icelandic horse trainers. Riders are formed into international teams. These teams receive instruction and compete together following the FEIF rules. The FEIF Youth Cup description:

- Age: 14 – 17 years
- Friendship across borders
- Qualification for best all-rounders
- Many tests, tests ask for medium skills in riding - Lectures in groups, gain experience
- Learning the practice of teamwork
- Horsemanship and sportsmanship
- Communicate in another language (English)

### **Team Prerequisites including Riders, Country Leader and Team Leader**

Riders, Country Leader and Team Leader must be members in good standing of the United States Icelandic Horse Congress at the time of application and at the time of the event.

## **Rider Tryout Process**

One copy of a short (5-10 minute) USB flash drive is required showing a Tölt (T1 or T2) program, AND a four-gait (V1), or five-gait (F1) program. For a description of the required tests, visit <http://www.feiffengur.com/documents/fipo2015.pdf>

Try-out videos must be made no earlier than January 1, 2015 and no later than November 27<sup>th</sup>, 2015.

Programs that have already been scored at a USIHC sanctioned show may not be used.

The same FEIF judge will judge all the programs.

The minimum score to qualify in each program is 4.5.

Try-out entry deadline is December 1, 2015.

Finalists will be notified by January 22, 2016.

In the event we do not have a full team at the time of the team announcement, late applicants will be accepted until the team is full or the FEIF deadline for submission of the US team whichever comes first.

Riders who make the team are allowed to compete in any event at the Youth Cup.

### **Rider Selection Process**

Following the evaluation of all video submissions, rider scores will be decided by taking an average of the totals for the two programs.

The team shall be selected by first taking the highest qualifying average of both tests: T1 or T2 and V1 or F1. The remaining spaces on the team shall be filled in descending order until a full team is formed or there are no more qualifying combinations.

Ties between riders are broken as follows:

The youth cup team selection committee will evaluate recommendations and experience. The judges will be asked to provide seat/aid scores when they evaluate all the videos. The rider who's better in the most categories will be selected. For example:

Rider A: average of both videos: 7.5

Rider B: average of both videos: 7.5

Rider C: average of both videos: 7.2

Rider D: average of both videos: 7.2

For riders A and B, tiebreakers would be unnecessary because both would be selected for the team.

For C and D, we will use our tie breaking method. The two riders will be compared and the youth cup selection committee will assign first and second place for:

- Recommendations
- Experience
- Seat/aid scores – (scores provided by judges.)

The rider who gets the most first places will be selected.

In the past, we have sent at least three riders. We will also select

alternates.

Selected team riders must pay the appropriate fees.

### **Country Leader Application Process**

Application entry deadline is December 1, 2015.

Country Leader will be notified by January 22, 2016.

If at the time of team notification we do not have a US Country Leader, the deadline will be extended based upon the FEIF deadline for submission of Country Leaders.

## **FEIF Youth work – lights, camera, action!**

### **International video competition 2015**

**What:** team competition for a group of 4-6 young riders involved with the Icelandic horse. You need to produce a video no shorter than 3 mins, and no longer than 5 mins on a particular theme.

**Theme for 2015: Happiness is ... [fill in your own idea]**

**Aim:** to foster teamwork and collaboration, encourage good horsemanship and continuous learning, raise awareness of the international aspects of the Icelandic horse world, develop imagination and promote perseverance to manage and complete a project.

**Who:** groups of young people, involved with Icelandic horses. The competition is open for groups of minimum 4 and maximum 6 young people, no older than having their 21<sup>st</sup> birthday during 2015.

**How:** as a minimum requirement, the film needs to involve at least one Icelandic horse, and must feature at least half the registered group. All other aspects (story, setting, music, etc.) are free for the team to agree on. Each team member needs to have a clearly defined and identifiable role in the production. Language – remember that the resulting film will be shown to an international audience, so keep dialogue to a minimum.

The video must have a title and credits, date, and venue, and other formal aspects for a proper video.

**When:** all videos need to be uploaded to youtube or similar, but remain “unlisted” and the video must not be made public until the end of August 2015. The link will be sent to [youth@feif.org](mailto:youth@feif.org), **no later than 31<sup>st</sup> May 2015**. Entries will be judged by an international panel of judges.

(If technically possible,) the winning entries will be played live on the big screen during the World Championships in Herning.

**Note to parents and youth leaders:** The competition is aimed at the young riders themselves. No equipment other than a video camera or mobile phone, and basic software on the computer should be necessary. In the spirit of international youth work, we would kindly request parents and other supportive adults to enable and support the work of the competing teams, without (!) getting too involved in the process, and to keep any potential costs to an absolute minimum.

**Note:** Riders shown on a horse must at all times wear a helmet.



Hi Juli, I will try to reformat this to an outline form... feel free to correct me or reject if it isn't right. This is all very new to me. Hard to teach an old dog new tricks.... this is brief, I don't want it to be too long.

1. Leisure Riding Committee has discussed various issues regarding the general program of awarding and rewarding riders of Icelandic horses for what is generally accepted as Leisure Riding.
  - a. Renaming to Leisure Riding Program to follow more closely FEIF. This was suggested by BOD.
  - b. As in the former program, hours in the saddle, ground training, or driving will be counted hour for hour.
  - c. Varying from the former program, hosting a clinic, trail ride, or other gathering involving Icelandic Horses and their riders, attending a clinic either riding and/or auditing will count as 10 hours. This may seem like a lot at first glance, but as many know, preparing an event takes a great deal of time, time spent one does not get to spend riding their own horses. Plus there is often travel time and lodging involved for participants and their horses. We as a committee wanted to encourage our participants to keep learning about their riding both by hosting and attending.
2. Prizes would be awarded to the top participants, but of course will not have been selected or purchased ahead of time. Many of those answering queries said that actual prizes were not the main incentive, just the recognition in the Quarterly and website were hoped for. It was generally agreed that any awards would not be clothing, due to size/quality/gender issues.
  - a. Patches for hourly awards have been purchased in the past, and there are many left. It was generally agreed that we will continue to send those as they are earned.
  - b. Medals, Gold, Silver and Bronze are also in stock. They can be and will continue to be awarded to the top participants.
  - c. We discussed using gift cards as prizes for qualifying top participants. Those responding did like the idea of gift cards, as they could purchase a gift suitable to themselves. This follows the lead of other programs, such as the Breed Ambassador Programs.
3. It was generally accepted that there will be a small registration fee and form to be filled out and paid to USIHC to participate. That can be either annual or lifetime. And a discount for families should be considered. It is felt that registration will assist in managing the participants by acquiring current email, snail mail and phone numbers, and the small fee will be used to offset some of the cost to administer the program such as awards purchase and postage. It probably could not support the Program alone, just consider it to be a user fee. The fee might be part of the annual registration fee if the Board sees fit, or an additional fee if not. The committee discussed amounts as small as \$5, and as much as \$25. With those amounts in mind input from the BOD is hoped for.
