What is the Youth Cup?

The FEIF Youth Cup is a seven-day youth competition held every other year in Europe or Iceland. The FYCup is a well-supervised event that takes place after 4 days of training with prominent and experienced Icelandic horse trainers. Riders are formed into international teams. These teams receive instruction and compete together following the FEIF rules.

The FEIF Youth Cup description¹:

- Age range: 14 – 17 years. (rider must turn 14 the year of the competition and cannot turn 18 the year of the competition)
- Promotes friendship across borders
- Prizes for winners of all tests as well as for best all-rounders
- Many tests offered which ask for medium riding skills
- Lectures presented in groups
- Riders will gain competition experience
- Learn teamwork
- Focus on horsemanship and sportsmanship
- Communicate in English with non-native English speakers

Team Prerequisites including Riders, Country Leader and Team Leader

Riders, Country Leader and Team Leader must be members in good standing of the United States Icelandic Horse Congress at the time of application and at the time of the event. The USIHC youth committee recommends that you check the status of your membership using the current membership list at www.icelandics.org/membership/

If your membership is not current at the time you submit your application or at the time of the event, you will not be allowed to participate and/or your spot on the team will be revoked. It is your responsibility to ensure these requirements are met.

Rider Try-out Checklist:

- Completed rider application
- Instructor evaluation requested.
- Flash drive showing your try-out videos
 - Videos must have not been judged.
 - Videos must be made between January 1, 2015 and November 27, 2015
- USIHC membership checked and confirmed
- Entries must be complete and received by December 1, 2015.

Instructor Evaluation Forms

Instructor Evaluation Forms can be found on the USIHC website at www.icelandics.org/youth/youthcup2016. Evaluation forms must be received by November 27th, 2015.

This form must be completed by each applicant's riding instructor. The riding instructor should not share this evaluation with the applicant. The completed form should be sent directly to the selection committee at the address on the form.

Flash Drive Video Instructions

Send one copy of a short (5-10 minute) USB flash drive showing a tölt (T1 or T2) program **AND** a four-gait (V1) or five-gait (F1) program. For a description of the required tests, visit www.icelandics.org/fipo_rules.

Try-out videos must be made no earlier than January 1, 2015 and no later than November 27, 2015.

Programs that have already been scored at a USIHC sanctioned show may not be used.

The same FEIF judge will judge all the programs.

The minimum score to qualify in each program is 4.5.

Rider Selection Process

Following the evaluation of all video submissions, rider scores will be decided by taking an average of the totals for the two programs.

The team shall be selected by first taking the highest qualifying average of both tests: T1 or T2 and V1 or F1. The remaining spaces on the team shall be filled in descending order until a full team is formed or there are no more qualifying combinations.

FEIF YOUTH CUP 2016 RULES AND PROCEDURES

Ties between riders are broken as follows:

1. The youth cup team selection committee will evaluate recommendations and experience.
2. The judges will be asked to provide seat/aid scores when they evaluate all the videos.
3. The rider who's better in the most categories will be selected.

For example:

Rider A: average of both videos: 7.5

Rider B: average of both videos: 7.5

Rider C: average of both videos: 7.2

Rider D: average of both videos: 7.2

For riders A and B, tiebreakers would be unnecessary because both would be selected for the team.

For C and D, we will use our tie breaking method.

First, we will compare seat/aids scores. The rider with the highest combination will be selected. If there is still a tie, the youth cup country leader and team leader selection committee will assign first and second place for:

- Instructor Evaluation
- Rider Resume

The rider who gets the most first places will be selected.

In the past, we have sent at least three riders. We will also select alternates.

Selected team riders must pay the appropriate fees as determined by FEIF. The team members will also be responsible for their own travel expenses.

If at the time of team notification we do not have a US Country Leader, the deadline will be extended based upon the FEIF deadline for submission of Country Leaders.

2. CL will attend daily meetings with the FYCup and Team Leaders and must attend the end of event summary meeting and provide a summary of your experience. It is important to be on time for every meeting.
3. CL ensures your team's horses are vaccinated by the international rules. This is CL responsibility.
4. CL is responsible for the horses and ensuring the stables are left tidy the FYCup team.
5. CL is required to sleep with the participants of your country.
6. CL is responsible for enforcing the sleeping hours (horses and people).
7. CL will participate in flag raising in the morning and evening.
8. CL is in charge of the lodging of the participants and ensures that the rules are followed. (Enforces quiet time after 23.00-23.30 hours)
9. CL is responsible for following riding rules set by FYCup. For example, if only light riding is allowed, then he/she will only allow lunging, walking or countryside riding.
10. CL is the 'mother' of the team! Makes sure that the team is doing well.
11. CL is responsible for bringing your country's trophies and flags to the FYCup.

The USIHC will provide reimbursement of up to \$1000.00 for travel expenses for the Country Leader.
