#### **SECRETARY'S REPORT (Sherry Hoover)**

#### TREASURER'S REPORT (Kari Pietsch-Wangard)

The monthly financial statements now include a detailed breakdown of the cash owned by the Congress. The key figures from the breakdown are:

Sport Committee - Asta Covert. There have been 5 inquiries about the application for the 2019 World Championship Show.

Quarterly Committee - Nancy Marie Brown. Report attached.

Youth Committee - Linda Templeton. Janet, who is also on the committee reported that the committee is gathering youth activities that have been successful and compiling these activities in one place for review.

#### **Old Business:**

Policy 33 Breed Evaluation Education. Sherry Hoover will draft the policy and present it to the breeding committee for their input.

#### **New Business:**

Clarification of Policy 31 Regional Club Clinic or Schooling Show Support (2019). Interpretation of eligibility requirement #1. Which reads in part; "The event details must be submitted to both the Affiliated Club Committee Chair and the USIHC Secretary for inclusion in the USIHC Calendar of Events no later than 1 month (30 days) before the event." The board noted that a club may have more than one event on the USIHC Calendar of Events, Policy 31 only allows funding of one event by the USIHC in 2019. Clubs MUST notify the Affiliated Clubs Chair about each event they add to the calendar that may request Policy 31 funds.

Sigrun Brynjarsdottir has submitted the Cobleskill, NY Breed Evaluation Funding Application Form. Sigrun has been informed that this breeding evaluation is the second breed evaluation to be held at the same location and funding was received last year. Therefore this breed evaluation is eligible for funding of a second event on the sliding scale of the sanctioned and funded USIHC events in the amount of \$500.

Virginia Lauridsen has submitted the Iowa Breed Evaluation Funding Application Form. This breeding evaluation is also the second breed evaluation to be held at the same location and funding was received last year. Therefore this breed evaluation is eligible for funding of a second event on the sliding scale of the sanctioned and funded USIHC events in the amount of \$500.
