## 2. TREASURER'S REPORT (KARI PIETSCH-WANGARD)

## 4. 2020 USIHC Budget

The USIHC is a non-for-profit organization registered for educational purposes as a 501C4. This means that the organization is not considered a charity and donations are therefore not tax exempt. The 2020 budget was discussed and approved. Upon a few amendments, it was circulated to all board members and received approval on 02/12/2020. The 2020 budget is attached to these minutes.
