

## USIHC Board Conference Call Agenda August 11, 2020 8:00PM (Eastern)

**Present:** Will Covert, Lori Cretney, Lucy Nold, Emily Potts, Leslie Chambers, Janet Mulder, Virginia Lauridsen, Martin Nielsen.

Will Covert called the meeting to order at 8:03 EST.

#### 1. SECRETARY'S REPORT (MARTIN NIELSEN)

As of August 11, 2020 the USIHC has 762 Members in 580 Households.

#### 2. TREASURER'S REPORT (KARI PIETSCH-WANGARD)

The board discussed forming a separate DNA registration subcommittee, and the Virginia will bring this to the breeding committee and encourage suggestions for committee members.

They are asking for feedback regarding the breakdown there. It could be as simple as 10 \$50 cards, but any value is possible, like 20 \$25 cards, for example. The board decided to offer 10 \$50 giftcards as a raffle for both S2SS riders (1) and virtual show riders (9). Martin will communicate this to Smartpak and get a partnership contract finalized with Emily Potts.

#### a. Initial discussion on reviewing USIHC policies for antidiscrimination.

Emily Potts is leading this initiative with focus on the following items:

- Appropriate implicit bias training for all board members. Emily is initiating a Google doc with appropriate training resources. All board members should complete training before 12/31/2020.
- Code of conduct statement to be revised. Emily will be circulating a suggested new verbiage.
- Review current policies and adding anti-discrimination clauses, where appropriate. The most appropriate text to address appears to be the Committee Membership Policy.

Emily will gather this information for next meeting.

#### 12. New Business

#### a. Awards for the fall virtual show.

The board discussed awarding a combination champion and reserve champion for each division. The open and intermediate divisions will be separated into fourgait and fivegait winners, making it seven divisions total. Leslie Chambers made the motion to allocate and additional \$60 to pay for such awards. Lori Cretney seconded the motion. The board voted unanimously in favor. The amount was subsequently adjusted to \$210 and approved by the board via email on 8/12/20.

The board also discussed class sponsorship and decided for \$25 per class and \$50 for sponsoring a division combination award.

#### 13. Miscellaneous.

The next meeting will be held on the Zoom platform. Martin Nielsen will set the meeting up. Call-in options will be available as well. Next meeting will be on September 15, 2020.

#### US Trainer Certificate Committee Meeting Minutes July 22, 2020, 8 pm Eastern Time

*Members present:* Laura Benson, Carrie Brandt, Caeli Cavanagh, Virginia Lauridsen (chair), Jana Meyer *Members Absent:* Coralie Denmeade, Alex Pregitzer

The US Trainer Certification Committee met through Zoom on July 22, 2020.

Members relayed that they had completed discussions on the questions assigned to the two groups. Caeli suggested the next step would be to send the finished questions to the committee advisors. She volunteered to clean up the language and email the document to the advisors.

There is a small section of the FEIF theory requirements yet to be addressed by the committee. Members agreed to divide them as follows:

Teaching Skills (Jana/Caeli):

Use appropriate teaching content

Apply appropriate didactics

Safety

Be able to use different approaches according to student's needs

Training Skills (Laura):

Basic horse training and understanding of bio-mechanics *General Knowledge:* 

History of riding and horsemanship (*Carrie/Laura*)
Horse Behavior (*Carrie/Laura*)
Knowledge of Icelandic Horse Associations (*Coralie*)
Preventing accidents in keeping and riding a horse (*Alex*)
First aid for horse and rider (*Alex*)
Business management; awareness of customer oriented business (*Alex/Carrie*)

Members then made a list of issues to think about before the next meeting:

Judges – who will judge the exam? Other practical considerations (i.e. location, horses, riders) Qualifications for the fast track exam How to run the theory exam; divide questions into levels of difficulty and put into groups?

Carrie asked if the education committee voted on the "creative structure document." Caeli, Laura and Virginia confirmed it had not. Virginia suggested that since the certification committee was appointed by the education committee with the task of creating a certification process, then it need only be approved by the sub-committee. She will confirm. Carrie will tweak the document and send it to the sub-committee. Members then suggested ideas for the exam requirements. Jana suggested that applicants deliver a "Zoom lecture" that anyone could watch about an assigned topic. Perhaps 25 minutes in length with a 5 minute Q & A following. Carrie suggested a 15 minute "Intro to the Icelandic Horse" Demo; such as you might give at an expo or for a first time student or visitor. Virginia agreed to create a "Brainstorming" googledoc for more ideas.

The meeting adjourned at 9 pm. Eastern time
