

USIHC Board Conference Call Minutes June 8, 2021

1. SECRETARY'S REPORT (MARTIN NIELSEN)

As of June 8, 2021 the USIHC has 782 Members in 600 Households.

2. TREASURER'S REPORT (LORI CRETNEY)

Reports are attached. The monthly financial statements now include a detailed breakdown of the cash owned by the Congress. The key figures from the breakdown are:

Combined bank account balances as of 5/31/21: \$137,440.27.

Unrestricted membership funds as of 5/31/21: \$120,796.63.

7. PROMOTIONS AND WEBSITE REPORT (EMILY POTTS)

8. QUARTERLY COMMITTEE REPORT (NANCY BROWN)

Nothing to report. The next deadline is July 1st.

9. SPORT COMMITTEE REPORT (MARTIN NIELSEN)

We have received this year's first application for an in-person National Ranking show (Montaire in October). There are nine entries for the virtual show and four videos uploaded thus far. The board briefly discussed maintaining last year's decision to keep national ranking scores valid for three years until show season has become more stable. Possibly even through 2022. The board will evaluate after this year's show season.

10. YOUTH COMMITTEE REPORT (LUCY NOLD)

FEIF and the Dutch youth committee is launching a virtual HestFest, which will be running for 6 weeks starting in July. Participating countries can take turns hosting the event by offering various virtual activities. The idea is to feature something that is unique to the hosting country. The board briefly discussed possible ideas which included putting together a video about the S2SS ride, video-documenting attending a show (perhaps one with other gaited breeds, which would be of interest to Europeans), obstacle courses, various lectures, watching a foal being born, etc.

11. Old Business

a. Stallion registry subcommittee

A subcommittee was appointed to work on the USIHC Stallion Registry. Committee members are Lucy Nold, Jeff Rose, Sherry Hoover, and Virginia Lauridsen (chair). In addition, Ásta Covert has been invited to join the committee.

12. New Business

a. Discussion of life-time USIHC membership offering

The board saw value in offering a life-time membership, so members don't have to worry about yearly renewals. Will Covert had investigated a few other US equine associations and most offer a life-time membership for the equivalent of 20-30 years' worth of membership fees. Some also offer a life-time youth membership good until the member turns 18, which would be worth considering for the USIHC as well. The board will make a decision about this at the next meeting.

13. Miscellaneous.

The next meeting will be on July 13.
