

# USIHC Board Conference Call Minutes August 10, 2021 8:00PM (Eastern)

Will Covert called the meeting to order at 8:04pm EDT.

### 1. SECRETARY'S REPORT (MARTIN NIELSEN)

As of August 10, 2021 the USIHC has 778 Members in 600 Households.

Combined bank account balances as of 6/30/21: \$143,082.22.

Combined bank account balances as of 7/31/21: \$142,402.72 Unrestricted membership funds as of 7/31/21: \$125,201.56. Net Change from 6/30/21: \$(693.26).

### 9. SPORT COMMITTEE REPORT (MARTIN NIELSEN)

The spring virtual show have been completed, and the results announced. A total of 98 videos were submitted and judged. Leslie is working on organizing the fall virtual show and will be making a few adjustments. She has

updated the video instruction document, and the dates have been selected. Judges are to be identified, but we are seeking input from the judges' taskforce. We are also rethinking the virtual schooling show concept with input from the judges' taskforce.

### 11. Old Business

### a. Continued discussion of life-time USIHC membership offering

Membership fees had not been adjusted for the past 15 years, and with increasing costs for the Quarterly, Pay-Pal, website and general inflation, the board felt that an adjustment was appropriate. Martin Nielsen made the motion to make the following adjustments:

Youth: \$50/year

Lifetime membership (until the member turns 18 years): \$280

Adults: \$60/year Three-year membership: \$150 Lifetime membership: \$1200

Family membership: \$80/year Foreign Friends: \$80/year

Leslie Chambers seconded the motion and the board voted unanimously in favor. Martin will draft an announcement of the new membership fee structure.

### 12. New Business

### a. Dressage All Breeds.

The board discussed the participation of USIHC members in All Breeds Dressage events. There had been some interest among the membership, and the board found it most appropriate to continue paying the membership fee and remain engaged for three (i.e., two additional) years before the value could be assessed. Janet Mulder suggested that these activities would fall under the sport committee, which Martin Nielsen agreed with.

Virginia Lauridsen made the motion to remain engaged for three years. Martin Nielsen seconded the motion and the board voted unanimously in favor.

### 13. Miscellaneous.

The next meeting will be on Sep 21.

The meeting was adjourned at 9:11m EDT.
