Reports of Officers:

President's Report: Virginia Lauridsen-

A letter is requested by Nicole Kempf for her Visa renewal. She is asking for a letter of recommendation and wants it to be on letterhead. A discussion was had if we should do this. It was agreed we would, since there are no level 4 trainers in the US, but she should be encouraged to become an USIHC member. Adding the water mark logo was discussed to use as there is no specific letter head.

Payment for virtual education series number three. \$300 was spent on the speaker but it was noted that the speaker had significant help and Virginia wants to compensate the assistant. Virginia motioned to pay them \$150, Jeff seconded and all if favor. It was agreed in the future to add such expenses into the budget.

Secretary's Report- Sara Stewart (membership numbers, 815 members and 619 households)

There was a loss this month because of several bills hitting at the same time, including the quarterly and national ranking website updates.

Reports of Committees

Affliated Clubs - Leslie Chambers nothing to report

Breeding Committee- Virginia Lauridsen.

Breeding Assessment in May at Montaire. The breeding tools cannot be put in carry on luggage and would have to be with checked luggage and there is a concern of them being lost. Shipping of breeding tools makes most sense, via Fedex. Virginia will ship them, USIHC will pay. This will be added to the policies and procedures that the USIHC will pay to ship the tools for each assessment and the tools will live with the breeding leader.

Education Committee- Jeff Rose. Nothing to report.

Leisure Committee - Janet Mulder see reports attached. Approximately 97 participants.

Sport Committee- Asta Covert

The sport committee has been discussing if Pace events should be allowed at breeding shows. Everyone is agreeing that exceptions are not the way to go but rather make a rule for the Pace to be offered at appropriate events where judges are available and the track is approved. A discussion was had about this and it was agreed that as long as the track, judges and time equipment is all appropriate it would be allowed. The national ranking fee would need to be paid and application submitted to the sport committee. Also to follow FEIF rules, horses cannot be overworked, cannot do breeding assessment and P2 in the same day. Virginia and Leslie motioned, Asta seconded, all in favor. Motion passed.

The first show of the season is coming up starting with CIA open on April 15-16 in Santa Ynez, CA followed by Gamankeppni in Prospect KY April 29-30

The rules have been updated to reflect the changes in the FEIF rules. And those will be posted on the website when finally approved by the committee. see attached.

Youth Committee- Lucy Nold. Additional spot for FEIF youth camp. The fourth applicant is qualified. Everyone agreed 4 spot should be applied for. Lucy will request from FEIF. Youth cup discussion, Caeli is requesting USIHC to give the money she collected from the last youth cup to the organizers of this years cup. The money is currently being held by USIHC. It was discussed the pros and cons of the money running through the USIHC for the youth cup. The current organizers nor host want to collect the money from participants. Virginia offered to collect it. It was also discussed that the USIHC could set said money aside from current participants for the next youth cup. The funds for this years cup have been raised by donations. Jeff recommended the USIHC be named as additional insured for the youth cup.

Promotions and Website - Emily Potts. Horses of Iceland contract renewal. Partnering with other countries and requesting printing rights so we can distribute booklets at expos and such. Banners are on their way, national ranking almost updated. Membership welcome packet takes a lot of time and money. Discussed moving to digital welcome packed instead of print. Agreed excellent idea, saves \$1200.

Old Business-

Website updates, Virginia is updating the breeding page with Emily. Everyone let Emily know where and what is outdated and she will fix/update.

Regional championships...Maggie and Virginia agreed to do regional championship but don't want to pay for another award. It was discussed tabling regional and or national championships until next year. Discussion points....adding an "award" wasn't really the point, concerns of if we are big enough to do a national championship, and the country is too big, all other sports have such championships, have to start somewhere, even if its small. Laying our shows geographically leading up to it to help make it happen, looking ahead for planning, location would change, be held every other year possibly, to be discussed more in sport committee.

New Business-

A discussion was had about the Riding Badge program, about re-writing it, as it is currently not easily understood (the tests are confusing). Our program was directly translated from the German program. Virginia suggested it be taken to the education committee, and Jeff agreed to begin the discussion with Carrie and Caeli.

We do not currently have any USIHC dressage tests, but many shows are offering dressage classes. Leslie has two that were written for the NEIHC by Jana and Alex. Virginia has some from Germany that Silke Feuchthofen gave her, but they are in German. Janet volunteered to work on this project and take it to the Sport Committee.

Lifetime Achievement award, Caeli requested a budget of \$3000 to order medals. The board voted to wait and see the number of applicants this year before ordering, as our budget was determined in February.
