Reports of Officers

President- Virginia Lauridsen, world championships, educations series, show schedules, marketing proposal from Ann Hoekstra.

Possibility of show circuit/season to help facilitate more people to attend traveling shows. Schedule timing to make it feasible to attend multiple shows when going far distances. Ann Hoekstra, illustrator, sent Virginia an email and wants to write a book and have it on our website. Virginia will connect her to Emily for proposal, maybe for quarterly.

Secretary- Sara Stewart (membership numbers) Sara absent at beginning of meeting, Emily reported numbers 827 members and 633 households.

Treasurer- Lori Cretney (see reports attached) Loss in July due to wild apricot bill, they raised their rates. August net income. Trainer certifications everyone is paid up except for one. Tests have to be completed within two years if tests weren't passed, it has to be paid within that time also. (Exact wording cannot be found with we told them, so for now we are going with that person has two years to pay.) Next time we will have better wording. If not paid, said member will not be in good standing anymore.

World Championship 2023

(This is just a short review of the team's experiences at the World Championships in Oirschot 2023. I will write a more detailed document to assist the board and future team leaders with making this process easier and maybe more stream lined.)

As you all know I came into the position of the team leader very unexpected and rather late which meant that I immediately had to dive into gathering information and getting to work. Very helpful was that Carrie had already set up a team conversation on a communication platform-GroupMe- which proofed to be great for quick communication. She had also looked over and edited the contracts for team members, though there are still a couple of topics that could be clarified and edited.

There was a fair amount of work involved in reading and filtering through documents from FEIF and the organizers, gathering all the necessary information from riders and team members and making sure that you receive everything in time and forward, register and book everything in a timely manner.

Both Susanne Froehlich at the FEIF office as well as Marc Dusseau, the organizer were incredibly helpful and always quick to respond to any questions.

The team members submitted their information to me mostly on time, but I was very glad to have built in generous time buffers as they were needed in a couple of cases.

Various team members were able to organize some sponsors for clothing but this is something I would highly suggest to get streamlined for the future. (All around- getting the clothing was not a satisfying factor this year.)

A few days before the travel to the Netherlands we had a zoom work shop session with an equestrian performance coach which I had sponsored for the team. We got some helpful tips on how to prepare mentally for such a big event and it was great to hear everyone's reason for why they wanted to do this, their worries but also their hopes and dreams.

Upon arrival in Oirschot the mood in the team was very good. Everyone was open, kind and helpful. We had a short team meeting each day where we talked about training times, information that was passed along throughout the day, things that needed to happen.

We kept our fridge stocked with drinks, fruit and some chocolate and the team tent was a place often seeked out by the members.

The official events started with the fit to compete and shoeing check, which all of our horses passed without any concerns.

Once the competition started everyone went a bit more their own way but the riders always watched each other compete as long as the schedule allowed.

Though many events did not go as hoped for, everyone took it in stride and kept their heads up looking ahead.

I think all in all it was a good experience for everyone and we all learned a lot. Everyone got inspired and all of our minds got working on how we can improve the whole process and the US team's presence for future years.

Thank you for giving me the chance to go along as the team leader and I am looking forward to being part of the process in years to come.
