- 1. First issue hiring a bookkeeper to work on the financials. Jeff motioned, Lucy 2nd, unanimous vote.

 - 2. Virginia is working with a local (DesMoines) CPA to help with the transition. She is willing to help through February. Lori will work on exporting the QB raw data.
 - 3. Lori will stay on through the end of the year, but the transition to the new bank (US Bank) in Iowa will have some details outside her purview.
 - 4. USIHC will post the description online shortly.

 - 1. Emily to help with the posting
- The new bank account will starting up shortly, and the account will transition from Associated Bank in Wisconsin (local bank) to US Bank (national bank)
